Proof of Residency is required for the person whose name appears on the Right of Interment. The resident rate is available to current residents of West Vancouver who can provide two of the following acceptable proofs of residency: valid BC driver's license, BC Health Care Card or BC ID Card showing full legal name and address; current utility bill (electricity, gas, cable, or telephone) showing resident's full legal name and address; current year property tax notice or current BC Assessment notice, showing resident's full legal name and address; current Owners Certificate of Insurance and Vehicle Registration.
