- (2) Accessory buildings shall not be located within a rear yard

<b>551.06</b>	<b>Side Yard</b>

7.6 metres minimum on each side of the building

7.6 metres maximum

**551.08 Number of Storeys**

2 storeys maximum

**551.09 Off-Street Parking**

1 parking space for every 3.3 beds, minimum

## 560 - PA1 - Public Assembly Zone 1 (Schools)

- (c) combined school
- (d) elementary school

<b>560.02</b>	<b>Conditions of Use</b>
---------------	--------------------------

- (1) Assembly uses are permitted as an accessory use to schools
- (2) Temporary classroom buildings are permitted accessory to schools

<b>560.03</b>	<b>Site Area</b>
---------------	------------------

- (1) Elementary school - 1.6 hectares minimum
- (2) Combined school - 4.0 hectares minimum
- (3) Secondary school - 4.0 hectares minimum

<b>560.04</b>	<b>Site Coverage</b>
---------------	----------------------

40% maximum

<b>560.05</b>	<b>Front Yard</b>
---------------	-------------------

9.1 metres minimum

<b>560.06</b>	<b>Rear Yard</b>
---------------	------------------

9.1 metres minimum

**560.07 Side Yard**

- (1) Side yard – a minimum of 10% of site width, to a maximum of 3 metres
- (2) Combined side yard – the greater of 6 metres or 25% of site width minimum, but need not exceed 30.4 metres

**560.08 Building Height**

- (1) Elementary school - 7.62 metres maximum
- (2) Combined school or Secondary school - 9.1 metres maximum

**560.09 Number of Storeys**

- (1) Elementary school - 2 storeys maximum
- (2) Combined school or Secondary school – 2 storeys maximum

**560.10 Off-Street Parking**

- (1) Elementary school - not less than 1.25 parking spaces for every classroom
- (2) Secondary school - not less than 1 parking space for each teaching and non-teaching employee plus one parking space for every 10 students attending Grade 11 and 12
- (3) Combined school - not less than 1.25 parking spaces for every classroom plus one parking space for every 10 students attending Grade 11 and 12
- (4) A loading space for the use of school buses shall have a minimum width of 3 metres and a minimum length of 9.1 metres
- (5) An elementary school constructed after December 1, 1998 shall provide a minimum of 2 off-street loading spaces for the use of school buses
- (6) A secondary school constructed after December 1, 1998 and a combined school constructed after 1998 December 1st shall provide a minimum of 3 off-street loading spaces for the use of school buses

  - (3) Lot C District Lot 1074 Plan 21190,

  - (5) Lot 9 Block 23 Capilano Estates Plan 9253 and
  - (6) The North East Part of District Lot 1070 except the east 108.5 feet, part on Highway Plan 25 and part on Highway Plan 113

**561.02 Conditions of Use**

- (1) Accessory residential uses are for the accommodation of the minister, clergy, other official or the caretaker of the place of worship and located on the same site as the assembly use
- (2) Home based businesses are only permitted within a single family dwelling
- (3) Community services are permitted in places of worship

**561.03 Site Area**

Place of worship – 1,672.5 square metres minimum

**561.04 Site Coverage**

40% maximum

**561.05 Front Yard**

9.1 metres minimum

**561.06 Rear Yard**

9.1 metres minimum



**561.07 Side Yard**

- (1) Side yard –the lesser of 10% of site width or 6 metres, minimum
- (2) Combined side yard – the greater of 12.1 metres or 25% of site width minimum, but need not exceed 30.4 metres

**561.08 Building Height**

Place of worship - 13.7 metres maximum

**561.09 Number of Storeys**

Place of worship - 2 storeys maximum

#4712 **561.10 Off-Street Parking**

- #4712 (1) The greater of:
  - (a) 1 parking space for every 4.5 metres of pews or number of fixed seats, or
  - (b) 1 parking space for each 9.5 square metres of net floor space used for assembly purposes;
  - (c) plus 1.25 parking spaces per classroom
- #4712 (2) An accessory residential use shall provide a minimum of 1 parking space
