WHEREAS the District of West Vancouver is required to prohibit in-person attendance at committee meetings pursuant to the order; and

WHEREAS the District of West Vancouver has enabled public participation at committee meetings via electronic means to ensure openness, transparency, accessibility and accountability, including via the use of electronic communication facilities (video-conferencing software) for public participation;

THEREFORE BE IT RESOLVED THAT the April 27, 2021 Arts Facility Advisory Committee meeting be held without in-person public attendance.

A. Mafia with assistance from A. Young and B. Haden shared a draft presentation on the Arts & Culture Site Selection options. A draft of the public survey was also shared and feedback from the committee was encouraged and discussed.

A. Young and B. Haden shared a draft video presentation modelling what a new arts facility might look like in the two different sites.

Committee members provided feedback on the draft presentation noting the need to make it shorter and more engaging. Staff confirmed that the presentation, once finalized, would be spotlighted on the WestVancouverite.ca website.
