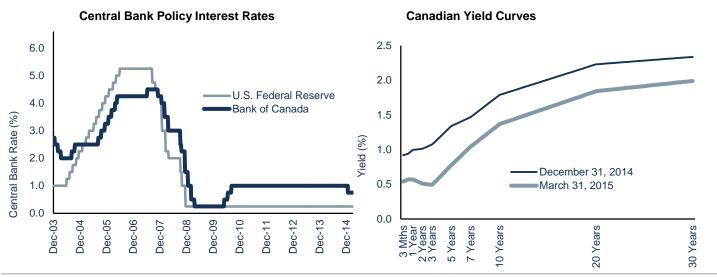

On the surface, March appeared to be a seemingly quiet month with yields ending the month modestly higher than where they began. It was, in fact, a relatively volatile month as uncertainty around central bank monetary policy drove market volatility. In Canada, the month began with yields heading higher with the expectation and subsequent announcement that the Bank of Canada (BoC) would not in fact cut the overnight rate in March. Rising yields were short-lived as a strong US employment report was followed by a number of weaker-than-expected US economic releases, sending yields lower. Finally, yields ended the month drifting higher as US Federal Reserve (Fed) Governor Yellen's speech once again stirred expectations of the Fed increasing the federal funds rate.

Overall, the yield curve steepened modestly with longer dated maturities ending the month roughly 7 basis points higher and the short end of the yield curve remaining roughly flat.

Market Outlook

The BoC met in March and held the overnight rate at 0.75%, as was foreshadowed by comments at the end of February by BoC Governor Poloz. That said, markets still expecting an additional rate cut by the BoC by the end of the year. While the Canadian economy has started to show signs of a broader recovery, the short end of the yield curve is likely to remain anchored for the foreseeable future so long as the BoC maintains an ultra-low policy rate.

Similar to the BoC, the Fed met in March and left the federal funds rate unchanged at its current level of 0.0% to 0.25%. While the Fed is still anticipated to be the first major central bank to raise its policy rate, with the consensus being that this will occur in the second half of 2015, the Fed's March statement had a noticeably more dovish tone, with the Fed reiterating that an increase in the federal funds rate remains data-dependent. Overall, we expect the short end of the yield curve to begin to rise as the impending rate increase nears.

Current Strategy

The Money Market Fund remains fully invested in high-quality short-term corporate securities as yield enhancement strategies continue to play a central role in the fund. High-quality short-term corporate securities continue to have an attractive yield advantage over similar term government securities. There is also a continued bias to bank-sponsored ABCP as there is a modest yield advantage relative to other corporate securities. Finally, the average term to maturity of the Money Market Fund continues to be longer than that of its benchmark, as the incremental yield available on these longer maturity money market securities remains attractive.

Similarly, yield enhancement strategies continue to play a key role within the Intermediate and Bond Funds. The Intermediate Fund utilizes provincial securities to achieve its government allocation, while maintaining a near maximum allocation to corporate credit. Conditions remain favourable for constructing a yield advantage in the Bond Fund through an emphasis on government agency, corporate credit, and mortgage exposure, over federal bonds.
