#### RECOMMENDATION

THAT the report titled, "Preventing Heritage Demolitions" outlining a framework for preventing the demolition of heritage buildings and resources and promoting heritage education and outreach in West Vancouver, be received for information.

#### RECOMMENDATION

THAT Council update the Community Heritage Register to add all nominated heritage resources identified on West Vancouver's heritage inventories.

#### RECOMMENDATION

THAT funding for a full time equivalent (FTE) heritage planner position to implement and manage the proposed heritage framework including the review and processing of heritage proposals be referred to the 2020-2024 Five-Year Plan Process for consideration.

# 1.0 Purpose

The purpose of this report is to seek Council's approval in principle for implementation of a framework and resources required to promote heritage education and awareness and prevent the demolition of heritage resources across the District.

# 2.0 Legislation/Bylaw/Policy

Local Government Act

Municipal heritage conservation tools and incentives are enabled under Part 15 of the *Local Government Act*. Continuing protection tools are described in Part 15, under sections 610 through 616, and include: heritage revitalization agreements, heritage designation, and heritage site maintenance standards.

A Community Heritage Register is a list of properties that are formally recognized by a local government for their heritage value or character. It is a tool for understanding and managing a community's heritage resources, and for accessing heritage conservation and incentive tools enabled by the Local Government Act.

# 3.0 Official Community Plan

On June 25, 2018 Council adopted the Official Community Plan that contains directions supporting the protection of heritage resources.

2.1.9 Protect buildings, structures and landscapes on the District's Heritage Register by:

- a. Allowing the conversion of single-family homes into multi-family use (e.g., duplex, triplex);
- b. Allowing fee-simple subdivisions or infill options (such as cottages or coach houses) on the same lot;
- c. Varying siting to protect valued trees and landscapes;
- d. Encouraging protection through bonus density and considering density transfer;
- e. Considering financial incentives (e.g., the reduction of development fees or charges, tax incentives);
- f. Reducing off-street parking requirements;
- g. Securing protection through Heritage Designation Bylaws;
- h. Supporting restoration through Heritage Revitalization Agreements; and
- i. Expediting the review process for the retention of heritage properties.

# 4.0 Background

#### 4.1 Previous Decisions

On June 19, 2006, Council adopted the Heritage Strategic Plan.

On November 26, 2007, Council established the West Vancouver Community Heritage Register.

On June 9, 2008, Council adopted selection criteria for additions to the Community Heritage Register and received for information a list of 171 historic places nominated to the Register by the Heritage Strategic Plan Implementation Working Group. Since that time Council has added a number of heritage resources to the Community Heritage Register with a total of 51 resources currently listed.

On February 19, 2018, Council approved the creation of a Heritage Advisory Committee along with a terms of reference for the Committee. Council also approved adding heritage resources identified on West Vancouver's heritage inventories to the Community Heritage Register.

On June 6, 2019, the Heritage Advisory Committee endorsed the draft staff report "Preventing Heritage Demolitions" and provided feedback to staff that is incorporated into the current report.

#### 4.2 History

West Vancouver contains a number of significant heritage assets. These assets vary from historic structures and buildings to significant landscapes and key historic features found throughout the community. The District has three heritage inventories, the first being the West Vancouver Heritage Inventory (1988) which identifies buildings generally built prior to 1945, the Heritage Landscape Inventory (1988) and the final inventory being the West Vancouver Survey of Significant Architecture 1945-1975.

The District also has a Community Heritage Register which formally identifies properties that are recognized for their heritage value or character. It is used as a tool for understanding and managing the community's heritage resources as well as for enabling the various heritage conservation and incentive tools enabled under Part 15 of the Local Government Act.

# 5.0 Analysis

#### 5.1 Discussion

The history of West Vancouver, including people, events and places, are an important part of what makes West Vancouver the unique and vibrant community it is. Throughout West Vancouver there are varied heritage assets which provides a strong sense of community identity through connection to the past. Increased awareness surrounding West Vancouver's character and the preservation of heritage resources is an important step to achieve the broad goal of preserving neighbourhood character and the more specific goal of preserving identified heritage assets such as signature dwellings and landscapes.

More recently, heritage properties (on the Register, captured in a District inventory or unlisted) within the community are coming under increased pressure from development. With the increased pace of development seen in the community in recent years, heritage resources are at an elevated risk of loss and destruction through significant modification or outright demolition. In several cases Council has approved a 60 day protection order in an attempt to encourage owners to consider heritage retention options. In most cases the heritage listed resource has still been demolished. On February 25, 2019, Council approved a temporary protection order for the Chin Residence at 1840 Orchard Way. At the time of approval Council discussion ensued requesting that staff report back in consultation with the Heritage Advisory Committee with a framework for proactive prevention of heritage demolitions. In response, several measures are recommended as part of a heritage framework to protect and educate on heritage resources in West Vancouver.

# Heritage Framework (summarized in Appendix A)

## a) Community Heritage Register Updates for Nominated Sites

The existing Community Heritage Register includes 51 heritage resources that have been previously approved by Council for addition. On February 19, 2018, Council approved, in principle, adding sites to the Community Heritage Register from the existing West Vancouver Heritage Inventories. Included as Appendix B is the updated register with all nominated sites in the "primary" and "secondary" categories added. The updated register includes 182 heritage resources.

For any of the resources that are not currently designated (i.e. protected by by-law) inclusion on the Community Heritage Register provides eligibility for incentives under Part 15 of the *Local Government Act*. It is noted that inclusion on the register does not mean that sites are protected and property owners are under no legal obligation. As well, staff note that inclusion on the register would not reduce property values and, in fact, could have a positive benefit with eligibility for incentives.

## b) Review of Heritage Best Practices

A key opportunity identified through discussion with the Heritage Advisory Committee is to conduct a comprehensive review of other municipality's heritage programs and policies. The review would be conducted to determine best practices and applicability for the West Vancouver context. Findings from the review would inform updates to the Heritage Strategic Plan and would streamline processing of heritage projects to incentivize heritage retention.

One key challenge identified by heritage applicants is the complexity and length of municipal application processing. A primary goal of the best practices review is the creation of a streamlined application process that would encourage heritage revitalization and protection as a financially viable option that preserves neighbourhood character while offering alternative housing options. For existing heritage property owners staff would also review potential incentives to encourage ongoing protection and maintenance of buildings and assets (e.g. allowing short term rental use for Community Heritage Register sites).

# c) Outreach and Education

A key initiative identified by the Heritage Advisory Committee for West Vancouver is the creation of an outreach and education program for community members, developers, realtors and property owners of heritage sites and resources. The intent of the program would primarily be to "get ahead" of potential heritage demolitions to provide education about the benefits of heritage protection. As part of the program, materials would be created promoting existing successful heritage projects to provide case studies for property owners and applicants to use in the development of heritage projects. Staff would create a unified heritage webpage to host materials and information for promoting heritage preservation. Other

consultation tools and promotional materials would be developed including the potential for a heritage plaque program and heritage awards for the District.

One key aspect of the outreach and education program is the goal to effectively partner with community organizations such as the North Shore Heritage Preservation Society and with other staff groups like Cultural Services to find synergies and efficiencies with other community outreach and education work being done. This aspect of the program is expected to reach beyond more traditional definitions of "heritage" promoting awareness of cultural and social heritage values and resources.

## d) Assess the "Support" Category Heritage Resources

Existing "support" category heritage resources are listed in the West Vancouver Heritage Inventories. Other than a name and other very limited details these potential heritage resources (183) do not currently include sufficient information to confirm merit for inclusion on the Community Heritage Register. Many of these buildings are under threat of demolition. If Council were to approve funding for a full time equivalent (FTE) heritage planner this position would first undertake the best practices review of other municipalities' heritage programs and incentives. An outcome of this review would be expected to determine the best approach for evaluation of the "support" category resources. This evaluation could involve a combination of researchers including staff, volunteers, summer students and/or consultants.

## e) Identification of Unknown Heritage Resources

West Vancouver's existing heritage inventories were mainly created through cursory "window pane" review of existing buildings and landscapes with additional research conducted for many of the "primary and "secondary" resources. Other sites and assets (including resources that have cultural and social or "storytelling" significance) that are not recognized on the District's existing heritage inventories are likely present across the District. With a full time heritage planner available to support policy development and implementation, education and outreach as well as incentive promotion and review, staff would have the capacity to review potential heritage resources across the District for inclusion on the Community Heritage Register. It is anticipated this could include "non-building" heritage resources (i.e. landscape, monument, cultural, etc.). Potential resources would be researched by staff and/or consultants and could also be brought forward by volunteers and community groups for review and evaluation by staff.

# f) Update Heritage Strategic Plan

The Heritage Strategic Plan, adopted by Council in 2006, outlined a series of action items, many of which have been implemented including the creation of the West Vancouver Community Heritage Register. With the initiation of the Heritage Advisory Committee there is an opportunity to review plan implementation and consider any relevant updates that should

be pursued including the potential to expand the definition of heritage to include celebration of cultural and social heritage resources. Staff and the Heritage Advisory Committee recommend updating the Heritage Strategic Plan to provide for coordination of heritage initiatives. If approved by Council, this work would be undertaken by the new full time heritage planner position in consultation with the Heritage Advisory Committee.

## 5.2 Staff Resource and Financial Implications

Staff recommend consideration for funding of a full time equivalent (FTE) position to manage implementation of the heritage framework and review and process heritage proposals. Staff note that funding for this position could, in part, be generated from increased revenues from planning fees. Included as part of the annual staff report on District fees (scheduled for consideration on July 8, 2019) are proposed fee increases for rezoning and development permit applications.

In considering how the existing "support" category heritage resources could be researched staff enquired with a heritage consultant to get a high-level cost estimate for the work associated with evaluating all "support" resources as part of a single contract. The heritage consultant provided an estimate of \$150,000 to conduct the research. At this time staff are not recommending that Council consider this funding request. The best practises review is expected to consider potential lower cost options for conducting the work including the use of a combination of staff, summer students and/or volunteers. If necessary after completing the best practises review staff will report back with any required funding request.

# 5.3 Sustainability

Retention and renovation of existing heritage buildings is a sustainable practise that avoids demolition and wasting existing construction and building materials.

# 5.4 Public Engagement and Outreach

If Council approves the funds required for hiring a heritage planner one of the main functions of the new position will be to work on engagement and outreach related to heritage issues and projects.

Staff recommend approval of the proposed recommendations to provide a framework and associated resources for proactively preventing demolition of heritage resources across the District of West Vancouver.
