# THE CORPORATION OF THE DISTRICT OF WEST VANCOUVER REGULAR COUNCIL MEETING MINUTES MUNICIPAL HALL COUNCIL CHAMBER MONDAY, JULY 21, 2014

#### **CALL TO ORDER**

**1.** The meeting was called to order at 7:04 p.m.

Mayor Smith informed that Council appointed Bahar Taheri and Katherine Tong to the Awards Committee, and at Council's last regular meeting the terms of reference for the Awards committee were amended to update current awards categories such as environment, heritage, arts and culture, civic commitment, and health, wellness and activity. Mayor Smith also informed that the West Vancouver Community Centre and Aquatic Centre was selected as the winner by the readers of the North Shore News in the category of favourite community fitness facility and that by receiving this award the public have recognized the Centre's ability to meet and exceed the community's expectations through its many programs and services for people of all ages.

A. Mooi (Director, Parks and Community Services) provided an update regarding beach closures due to high bacteria levels, informed that Vancouver Coastal Health monitors beaches in Metro Vancouver regarding bacteria levels during the swimming season, informed of public notifications, communications and signage on beaches, that the advisory warning would be in place until the bacteria reached acceptable levels, and that the public could contact Vancouver Coastal Health for additional information.

<u>Mayor Smith</u> informed that at the July 7, 2014 Council meeting there was a speaker who unfortunately got overlooked and invited Mr. Karim to come forward and speak at this time.

- <u>D. Karim</u> (752 Eden Place) spoke relative to the Maison Seniors' Living development, including: the developer and his representatives made a number of promises to mitigate objections and requested that the Planning department follow through on them so that the neighbourhood's interests are protected; list of covenants emailed on behalf of our neighbourhood, which are fundamental in maintaining our quality of life; requested that Council instruct the Planning department to incorporate covenants in appropriate permits; and urged Council to make sure neighbourhood interests are protected.
- <u>B. Sokol</u> (Director, Planning, Land Development and Permits) informed that a series of things are in place that were before Council at the public hearing and that those will be enforced by the Planning department.

<u>Mayor Smith</u> informed that we are going to monitor things to make sure that everything that was committed is going to be delivered to the neighbourhood.

#### **DELEGATIONS**

- 4. E. Finn, regarding Woodfibre LNG Limited Proposal for Liquefied Natural Gas Plant in Howe Sound (File: 0055-01)
  - <u>C. Cameron</u> (5420 Marine Drive) introduced E. Finn (3424 West 2nd Avenue) and spoke relative to the Woodfibre LNG Limited Proposal for Liquefied Natural Gas Plant in Howe Sound including: air quality and revitalized marine ecosystems since the Woodfibre pulp mill closed down; BC tourism jobs and sector revenues are worth more than oil and gas extraction, forestry or

agriculture; threats posed by LNG super tankers; and internationally accepted standards for the siting of LNG plants.

A PowerPoint presentation was provided and <u>E. Finn</u> spoke relative to the Woodfibre LNG Limited Proposal for Liquefied Natural Gas Plant in Howe Sound and concerns including: several industrial projects are proposed for Howe Sound; the 2008 Union of British Columbia Municipalities resolution against the passage of LNG tankers in Howe Sound; federal policy on LNG tankers; LNG tanker concerns including impact of spills and tankers travelling through Howe Sound; the Woodfibre LNG proposal and other related concerns.

Council members commented and <u>E. Finn</u> responded to queries of Council. MOVED by Gambioli, seconded by Cameron:

#### THAT

- the District of West Vancouver Council advise the environmental assessment office of our concerns regarding super tanker safety, rogue waves, foreshore erosion, conflicting waterway uses, and the LNG terminal in Howe Sound and tanker traffic, in response to their request for feedback on the Woodfibre LNG project; and
- 2. the District of West Vancouver be included in any existing and future committees, working groups and consultative bodies regarding the tanker traffic and location and operation of the LNG plant; and that
- the District of West Vancouver Council write to the federal government with a suggestion to ban the passage of LNG tankers in the waters of Howe Sound.

Council members commented relative to the proposed motion.

The question was called on the motion.

A PowerPoint presentation was provided and <u>L. Berg</u> (Senior Community Planner) described the proposed development permit. <u>L. Berg</u> and <u>B. Sokol</u> (Director, Planning, Land Development and Permits) responded to queries of Council.

A PowerPoint presentation was provided and <u>R. Amantea</u> (Vice President, Park Royal Shopping Centre), <u>J. Moorcroft</u> (Architect, Musson, Cattell, Mackey Partnership) and <u>M. Vaughan</u> (Landscape Architect, Vaughan Landscape Planning and Design Ltd.) described the proposed development permit. <u>P. Joyce</u> (President, Bunt & Associates Engineering Ltd.), <u>R. Amantea</u> and <u>M. Vaughan responded to queries of Council.</u>

Mayor Smith called for public input.

<u>C. Low</u> (935 Marine Drive) spoke relative to the proposed development including: the pedestrian overpass that was torn down and replaced with a three-way crosswalk and impact on pedestrians; reconnect tenants back to the South Mall; noise bylaws were not enforced during the Park Royal upgrade construction; and concerns regarding residents severely affected by these changes.

Councillor Soprovich left the meeting at 8:39 p.m. and returned to the meeting at 8:40 p.m.

A. Hylands (1430 Inglewood Avenue) spoke relative to the proposed development including: concerns regarding the traffic volume around Park Royal and the traffic congestion at Taylor Way and Marine Drive; concerns regarding access to the West Royal towers; no more apartment buildings; and asked please do something about the traffic.

<u>Mayor Smith</u> queried two more times if there was anyone else who wished to speak and there was no response.

<u>Councillor Soprovich</u> acknowledged Ms. Y. Wagner (Owner, 6003 Eagleridge Drive) for the work she has done in maintaining the property and heritage factors, and as a benefactor as upon her passing she is going to dedicate the property and home to the District of West Vancouver. <u>B. Sokol</u> responded to Council queries relative to supportive and non-monetary conservation incentives. <u>Councillor Gambioli</u> provided a suggestion to staff for a heritage home and garden tour.

<u>Mayor Smith</u> informed that N. Leemhuis (Chief Administrative Officer) will be bringing forward to Council later this year a proposal to reinvigorate heritage in West Vancouver, and step up our focus on heritage.

#### 8. Options for Marine Drive and Pound Road Intersection (File: 1805-01)

<u>P. Bates</u> (Manager, Engineering Services) and <u>N. Wong</u> (Transportation Engineer) displayed a map of the Marine Drive and Pound Road intersection, spoke relative to the subject report dated June 18, 2014 and lower level road considerations, time frame, traffic calculations, and discussions with stakeholders and feedback from user groups.

<u>V. Mendes</u> (Kings Avenue) spoke relative to the Marine Drive and Pound Road Intersection, asked that Council delay voting in favour of this report, commented regarding: user groups that have not been consulted; change.org petition with 450 people signed up; option of putting some sort of access on the back side parallel to the CN Railway; and asked that the motion be delayed for further consultation.

N. Brown spoke relative to the Marine Drive and Pound Road Intersection including: it has never been a good exit but people used it because they could do the overpass or loop through in front of the towers; traffic is now being pushed into Park Royal to loop back which increased congestion in the Park Royal Area; and it would be helpful to know that there is a solution rather than waiting 10 years for the potential low road connector plan.

MOVED by Cameron, seconded by Soprovich

- the "Options for Marine Drive and Pound Road Intersection" recommendation be tabled until such time as staff have had an opportunity to consult with the user groups and have had the time to determine more accurate costing and development of the feasibility of the various options available; and

Leemhuis (Chief Administrative Officer) referred to the three part recommendation set out in the subject report and suggested that a fourth part be added as follows: "That staff consult with user groups and stakeholders and provide further review and analysis of options to be brought forwarded in the fall of 2014."
