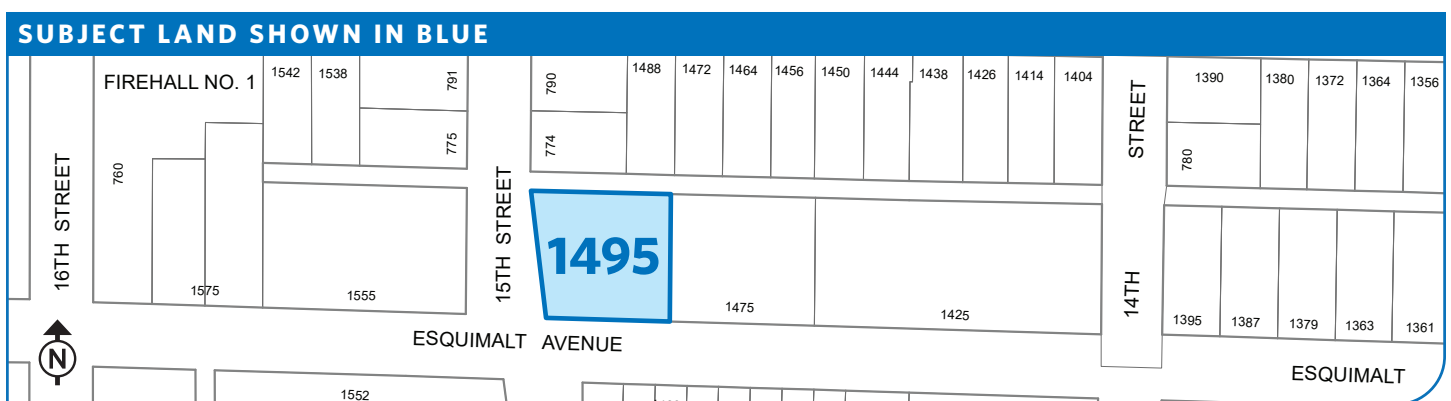


NOTICE OF CONSIDERATION
