- F. Pagani, Ferry Building Gallery Advisory Panel: The Ferry Building Gallery Advisory Panel has developed and approved their 2025 work plan. It includes creating a mentor program, and a fundraising event or series of events with the aim of raising \$10,000.
- L. Yu, West Vancouver Memorial Library: A fundraising event was held last Wednesday. S. Swan and K. Hall will be attending the Library Board meeting in December to present the priorities of the Arts & Culture Strategy Update.
- K. Burnett: The North Shore Artists' Guild has their winter art sale coming up. They have appointed a new president, Wanda Doyle.
- C. Schachtel, West Vancouver Community Arts Council: The Holiday Artisan Market takes place from November 13-24. The West Vancouver Community Arts Council is launching their annual fundraising campaign and have established a fund at the West Vancouver Foundation. Council will hold a strategic planning session in January 2025 to review the expectations of an umbrella organization, with the intent to reconfirm their mission and purpose statement.
- S. Price, Community Grants Advisory Panel: The Community Grants program has completed its yearly cycle, and members also reviewed the Permissive Tax Exemption applications, providing recommendations to Council.
- K. Hall, Art Museum Advisory Panel: The West Vancouver Art Museum has confirmed the appointment of a new Art Museum Administrator/Curator, Pantea Haghighi. The Geoffrey Farmer exhibition has been successful and received good media coverage.
- A. Repstock, Public Art Advisory Panel: The Public Art Advisory Panel is supporting a call to artists by the West Vancouver Police, to wrap a new Ford

F350 community vehicle. The public art project at Weston Park has been installed. The Advisory Panel will not be moving forward with a public art piece by Martha Sturdy in Ambleside Park east of the Ferry Building. They are in discussion regarding a different location.

• N. Brown, West Vancouver Board of Education: Heading into the Christmas season, schools are busy with musical performances and events.
