- e) I am NOT entitled to register as a resident elector in School District 45 (West Vancouver);
- f) I have NOT registered as a non-resident property elector in relation to any other parcel of real property in School District 45 (West Vancouver);
- g) I have received the written consent of the majority of individuals registered as owners of the real property to be registered as the non-resident property elector for this property (only applicable if there is more than one owner of the property); and
- h) I am not disqualified by the *Local Government Act* or any other enactments from voting in an election or am not otherwise disqualified by law.

* You must personally own property in School District 45 (West Vancouver), i.e. the property cannot be wholly or jointly owned by a corporation, business, or other organization (*Local Government Act* section 66).

INSTRUCTIONS FOR COMPLETING NON-RESIDENT PROPERTY ELECTOR REGISTRATION APPLICATION

1. You must meet the requirements in this section in order to register as a Non-Resident Property Elector in West Vancouver.
2. Print applicant's surname and given names in full here.
3. Print the address, municipality and postal code of applicant's residential address.
4. Print the mailing address.
5. This is information required pursuant to the *Local Government Act*, section 70(1)(b).
6. Print the street address or legal description of the applicant's real property for which the applicant is registering.
7. The elector *must* indicate Yes or No whether the property is jointly owned.
8. This information is to identify persons who have had a name change since the last election and who were on the list of electors.
9. Applicant must sign here.
10. A person who was present as a witness when applicant signed his/her name on line 9 *must* sign here.
11. The address of the witness must be provided here UNLESS the witness is an election official.
12. You must attach the "Non-Resident Property Elector Consent Form" if the land title registration of the real property in relation to which a person is registering shows that there is more than one individual who is the registered owner of the real property. The person registering must do so with the written consent of the number of those individuals who, together with the person registering, are a majority of those individuals. NOTE: The applicant must personally own property in West Vancouver, i.e. the property cannot be wholly or jointly owned by a corporation, business, or other organization (*Local Government Act* section 66).
13. If the person is registering at the time of voting, 2 pieces of identification (at least one with a signature) to prove identity and place of residence, are required pursuant to *Local Government Act* sections 72 and *Local Government Act Regulation 380/93* (pursuant to the *Regulation*, documents that may be accepted as evidence for the purpose of *Local Government Act* section 72 are:
 - a British Columbia Driver's Licence
 - a BC Identification Card within the meaning of the Identification Card Regulation
 - a photo BC services card within the meaning of the Identification Card Regulation
 - a non-photo BC services card within the meaning of the Identification Card Regulation
 - an Owner's Certificate of Insurance and Vehicle Licence issued by the Insurance Corporation of British Columbia
 - a British Columbia CareCard or British Columbia Gold CareCard;
 - a Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8
 - a Social Insurance Number card or confirmation of Social Insurance Number letter issued by the government of Canada
 - a Citizenship Card issued by Citizenship and Immigration Canada
 - a real property tax notice issued under section 369 of the *Local Government Act* or section 21 of the *Taxation (Rural Area) Act*
 - a credit card or debit card issued by a savings institution as defined in section 29 of the *Interpretation Act*, or
 - a utility bill issued for the supply of electricity, natural gas, water, telephone services or coaxial cable services by
 - a public utility as defined in section 1 of the *Utilities Commission Act*
 - a gas utility as defined in section 1 of the *Gas Utility Act*
 - a water utility as defined in section 1 of the *Water Act*
 - the British Columbia Hydro and Power Authority, or
 - a corporation licensed by the Canadian Radio-television and Telecommunications Commission for the purposes of that supply.
