- 5. This is information required pursuant to the Local Government Act, section 70(1)(b).
- 6. Print the street address or legal description of the applicant's real property for which the applicant is registering.
- 7. The elector *must* indicate Yes or No whether the property is jointly owned.
- 8. This information is to identify persons who have had a name change since the last election and who were on the list of electors.
- 9. Applicant must sign here.
- 10. A person who was present as a witness when applicant signed his/her name on line 9 must sign here.
- 11. The address of the witness must be provided here UNLESS the witness is an election official.
- 12. You must attach the "Non-Resident Property Elector Consent Form" if the land title registration of the real property in relation to which a person is registering shows that there is more than one individual who is the registered owner of the real property.
