Fees and Charges Bylaw No. 5334, 2024, Amendment Bylaw No. 5376, 2025

An Amendment Bylaw to correct an administrative error in Fees and Charges Bylaw No. 5334, 2024.

Previous amendments:

Fees and Charges Bylaw No. 5334, 2024, Amendment Bylaw No. 5366, 2024 adopted by Council on December 9, 2024.

WHEREAS the Council of The Corporation of the District of West Vancouver previously adopted Fees and Charges Bylaw No. 5334, 2024 to establish 2025 fees and charges for services and information;

AND WHEREAS an administrative error has been identified in the said bylaw that requires correction to accurately reflect Council's intent;

NOW THEREFORE, the Council of The Corporation of the District of West Vancouver enacts as follows:

Part 1 Citation

- 1.1 This bylaw may be cited as Fees and Charges Bylaw No. 5334, 2024, Amendment Bylaw No. 5376, 2025.

Part 2 Severability

- 2.1 If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed, and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

Part 3 Amendment of Regulations

- 3.1 Fees and Charges Bylaw No. 5334, 2024, is amended as follows:

- (a) In Section C – Licensing, to ensure completeness, the list of types of contractors is replaced with the following:
