Park Dedication Bylaw No. 4922, 2016

A bylaw to dedicate two lots in Ambleside Park

WHEREAS pursuant to Section 30 of the *Community Charter*, a Council of a municipality may, by bylaw adopted by 2/3 of all members of Council, dedicate municipal land for municipal park purposes;

AND WHEREAS the District of West Vancouver is the registered owner of the following municipal lands:

Parcel Identifier Number: 011-258-055

Legal Description: LOT 12 BLOCK 28 DISTRICT LOT 237 PLAN 4962;
and

Parcel Identifier Number: 011-258-144

Legal Description: LOT 17 BLOCK 28 DISTRICT LOT 237 PLAN 4962

(“**Ambleside Lots**”)

AND WHEREAS the Ambleside Lots were previously purchased for park purposes;

AND WHEREAS the Council of The Corporation of the District of West Vancouver deems it expedient to dedicate the Ambleside Lots as park;

NOW THEREFORE, the Council of The Corporation of the District of West Vancouver enacts as follows:

Part 1 Citation

- 1.1 This bylaw may be cited as Ambleside Park Dedication Bylaw No. 4922, 2016.

Part 2 Severability

- 2.1 If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

Part 3 Dedication of Ambleside Park Lots

- 3.1 The Ambleside Lots, namely, those lands legally described as follows and as shown on the attached Schedule A, are allocated, set aside and dedicated for park purposes:

Parcel Identifier Number: 011-258-055

Legal Description: LOT 12 BLOCK 28 DISTRICT LOT 237 PLAN 4962;
and

Parcel Identifier Number: 011-258-144

Legal Description: LOT 17 BLOCK 28 DISTRICT LOT 237 PLAN 4962
