If conditions are met, the Treasurer will recalculate the metered water utility fee for the most recent quarterly period by estimating the normal					
volume based on usage history and trends over the previous two years. The recalculated metered water volume utility fee will be the sum of the following:					
a) Normal volume multiplied by the unit rate in Schedule "B".					
b) Excess volume multiplied by 25% of the unit rate of Schedule "B".					
c) Water leaks administration fee in accordance with Schedule "C". Provided that the total recalculated fee as determined above is less than the original quarterly billing, the Treasurer may rebate the difference.
